UN HUMAN RIGHTS MECHANISMS

This course enables human rights defenders to learn about the UN human rights system and engage with the mechanisms thanks to practical information; training, support and assistance to enable them to better interact with the system.

Organized in parallel with the UN Human Rights Council session at the Palais des Nations in Geneva, the participants have the occasion to attend some sessions and meet with relevant human rights experts and mandate holders from the UN.
